A regular meeting of the Tea City Council was held at Tea City Hall on January 18, 2016 at 7:00 p.m.

**AGENDA. MOTION 16-07. MOTION** by Ortmeier, seconded by Weis to approve the, January 19, 2016 agenda. All members voted AYE.

**MINUTES. MOTION 16-08. MOTION** by Rieck, seconded by Fowlds to approve the January 4, 2016 minutes. All members voted AYE.

**LINCOLN COUNTY REAPRAISAL**. Lincoln County Director of Equalization Karla Harkness was present to discuss the property reappraisal that was conducted in Lincoln County. They have completed Delapre Township and the City of Tea. The preliminary assessment notices will be mailed on January 19<sup>th</sup>. Harkness also went through the process that they used for the reappraisal. They used the mass appraisal approach which is measured with statistics developed from a sample of sales in the entire area of the taxing jurisdiction. They look at the ratio between the assessed value and the market value. Before the reappraisal the median ratio was 81% of market value. After the reappraisal they are at 95% of market value. During the local review board process they will have a representative at the meeting to assist the board.

**HAGEDORN INDUSTRIAL PARK AMENDED PLANS**. Kevin presented and recommended approval of the amended plans for Hagedorn Industrial Park to include an additional lot. **MOTION 16-09. **BUILDING PERMIT DATA**. There were 180 permits issued in 2105 at a value of \$13,423,983.
