City of Tea Regular Meeting August 7, 2017

A regular meeting of the Tea City Council was held at Tea City Hall on August 7, 2017, at 7:00 p.m.

Mayor John Lawler called the meeting to order at 7:02 pm with the following members present: Sidney Munson, Brian Fowlds, Chuck Ortmeier, Joe Weis, Casey Voelker and Todd Boots. Also present: Finance Officer Dawn Murphy, Utility Superintendent Thad Konrad, Planning & Zoning Administrator Kevin Nissen, Police Chief Jessica Quigley, City Engineer Ben Scholtz and City Administrator Dan Zulkosky.

AGENDA. MOTION 17-138. MOTION by Fowlds, seconded by Ortmeier to approve the August 7, 2017 agenda with the addition of Executive Session for personnel. All members voted AYE.

MINUTES. MOTION 17-139. MOTION by Ortmeier, seconded by Fowlds to approve the July 24, 2017 minutes. All members voted AYE.

WARRANTS. MOTION 17-140. MOTION by Fowlds, seconded by Boots to approve the warrants as presented. All members voted AYE. Warrants will be listed at the end of the minutes.

LINCOLN COUNTY EMERGENCY MANAGEMENT. Harold Timmerman from Lincoln County Emergency Management was present to introduce himself and to remind the Council that they are available to help should the need arise.

2ND READING OF ORDINANCE 246. The Council held the 2nd reading of Ordinance 246. There were no additional comments. **MOTION 17-141**. **MOTION** by Boots, seconded by Ortmeier to approve and adopt Ordinance 246, An Ordinance of the City of Tea, SD Rezoning Lot 7, Block 4, Coffee's Addition from General Business Commercial (GB) to R2 Residential District and Amending the Official Zoning Map. All members voted AYE. The ordinance will be published separately.

LANDMARK INIDUSTRIAL PARK PLAT. Kevin presented and recommended approval of a plat in Howling Ridge Addition. **MOTION 17-142. MOTION** by Fowlds, seconded by Ortmeier to approve the following resolution. All members voted AYE. Motion carried. BE IT RESOLVED by the City Council of the City of Tea, South Dakota that the plat knows and described as Tracts B & C, Landmark Industrial Park Addition, lying within the platting jurisdictional limits of the City of Tea, South Dakota, is hereby approved and the City Finance Officer of the City of Tea, South Dakota is hereby directed to endorse on such plat a copy of this resolution and certify the same thereon. SITE PLAN. Kevin presented and recommended approval of a site plan Chad Javers to construct a 14,980 sq. ft. building to be used for contractor shops in the Southwest Industrial Park. **MOTION 17-143. MOTION** by Boots, seconded by Fowlds to approve the site plan for Chad Javers to construct a 14,980 sq. ft. building on Tract 25, Southwest Industrial Park. All members voted AYE.

INTIAL DEVELOPMENT PLAN – BAKKER LANDING DEVELOPMENT. Kevin presented C-Lemme Companies, Sundowner Investments, LLC's initial development plan for Bakker Landing Development to be located at north of Highway 106 and east of Sundowner Ave. There is a combination of light industrial, manufacturing, retail, office and mix-use commercial. There were no comments from the Council.

INITIAL DEVELOPMENT PLAN – WHISPER TRAILS ADDITION. Kevin presented Signature Companies, LLC's initial development plan for Whisper Trails Addition which is 55.15 acres located north of 271st Street and East of Main Avenue. At the July 10 2017 meeting there was discussion on the proposed 65' frontage lots. The plan now has fewer 65' frontage lots. The open space requirement will still need to be worked out. The Council was favorable for the development plan.

INITIAL DEVELOPMENT PLAN – PHASE 4 HIGH POINTE ESTATE. Kevin presented Nielson Development's initial development plan for Phase 4 High Pointe Estates. The proposed development is 24.69 acres, located north of High Ponte Street and West of N. Main Ave. and would consist of a combination of multi-family and single-family homes. There were no comments from the Council.

INITIAL DEVELOPMENT PLAN – PINNACLE ESTATES ADDITION. Kevin presented Nielson Development's initial development plan for Pinnacle Estates Addition. The proposed development is 37.30 acres, located north of 272nd St and east of Ceylon Ave. and would consist of a combination of single family and multi-family homes. There was discussion on lot frontages which range from 50 to 98 feet wide. There were no other comments.

85TH ST. PRE-ANENXATION. Kevin has been working with Sioux Falls on defining the 85th Street boundaries and the responsible parties for infrastructure.

EXECUTIVE SESSION. MOTION 17-144. MOTION by Boots, seconded by Weis to go into executive session at 8:34 pm pursuant to SDCL 1-25-2 (1) personnel. All members voted AYE. Council came out of executive session at 8:57 pm.

MOTION 17-145. MOTION by Fowlds, seconded by Ortmeier to adjourn at 8:58.
