WASTEWATER REGIONALIZATION. There was continued discussion on the future of the City's wastewater system. A decision needs to be made on building our own treatment plant or to join the Sioux Falls Regional Wastewater System. Disadvantages with regionalization are the initial System Development Charges, not having any control of the system and monthly pumping charges. Disadvantages with building a treatment plant are having higher initial rates, higher initial capital costs and future wastewater treatment regulations. MOTION 17-116. MOTION by Weis, seconded by Boots to enter into a Memo of Understanding (MOU) with the City of Sioux Falls to join the Sioux Falls Regional Wastewater System. Members Weis, Ortmeier, Boots, Voelker and Fowlds voted AYE. Member Munson voted NO. Motion carried.

SURFACE TREATEMENT CHANGE ORDER. MOTION 17-117. MOTION by Fowlds, seconded by Voelker to approve Change Order 1 for the Surface Treatment Program for removing 535 ft. of Kevin Drive and adding 11,805 square yards to N. Main Ave. for a total change of \$19,924.00. New total contract amount - \$158,241.00. All members voted AYE.

MEETING DATES. MOTION 17-118. MOTION by Fowlds, seconded by Ortmeier to move the July meeting dates from the 3 and 17 to the 10 and 24. All members voted AYE.

MOTION 17-119. MOTION by Weis, seconded by Fowlds to go into executive session pursuant to SDCL 1-25-2 (1) personnel. All members voted AYE. Council came out of executive session at 8:20 pm.

MOTION 17-120. MOTION by Weis, seconded by Voelker to adjourn at 8:26 pm. All members voted AYE.
