TIGER GRANT APPLICATION. MOTION 17-179. RESOLUTION 17-10-13. MOTION by Boots, seconded by Fowlds to approve the following resolution. All members voted AYE. WHEREAS, the City Council of the City of Tea has determined the need for the 271st Street (CR 106) Improvements Project – Phase 2; and WHEREAS, funding assistance is necessary to enable the City of Tea to construct these improvements; and WHEREAS, the City Council is desirous of applying for a TIGER Grant from the U.S. Department of Transportation for the purpose of completing improvements to 271st Street (CR 106); and WHEREAS, the City Council commits to contributing an estimated \$3,563,937.60 which is approximately 30% of the project cost.
