City of Tea Regular Meeting April 2, 2018

A regular meeting of the Tea City Council was held at Tea City Hall on April 2, 2018 at 7:00 p.m.

Mayor John Lawler called the meeting to order at 7:00 pm, with the following members present: Sidney Munson, Brian Fowlds, Chuck Ortmeier, Joe Weis, and Todd Boots. Also present: Finance Officer Dawn Murphy, Utility Superintendent Thad Konrad, City Administrator Dan Zulkosky and from HDR Engineering Ben Scholtz and Jason Kjenstad. Councilmember Casey Voelker was absent.

**AGENDA. MOTION 18-58. MOTION** by Ortmeier, seconded by Boots to approve the April 2, 2018 agenda. All members voted AYE.

**MINUTES. MOTION 18-59. MOTION** by Fowlds, seconded by Weis to approve the March 19, 2018 minutes. All members voted AYE.

**WARRANTS. MOTION 18-60. MOTION** by Fowlds, seconded by Ortmeier to approve the warrants as presented. All members voted AYE. Warrants will be listed at the end of the minutes.

**PINNACLE ESTATES ADDITION PRELIMINARY DEVELOPMENT PLAN.** Mayor Lawler opened the public hearing for the Pinnacle Estates Addition Preliminary Development Plan at 7:05 pm. Ben presented the plan and recommended approval. The property is located east of Artisan Addition. **MOTION 18-61. MOTION** by Boots, seconded by Weis to approve the Pinnacle Estates Addition Preliminary Development Plan for Nielson Development, W ½ of the E ½ of the SW ¼, 25-100-51. Members Munson, Ortmeier, Boots and Weis voted AYE. Member Fowlds abstained. Motion carried.

1<sup>ST</sup> READING OF ORDINANCE 254 PUBLIC HEARING. Mayor Lawler opened the public hearing for the 1<sup>st</sup> Reading of Ordinance 254, An Ordinance of the City of Tea, SD, Rezoning the W ½ of the E ½ of the SW ¼ Section 25-100-51 from Agriculture to Planning Development District and Amending the Official Zoning Map of the City of Tea. There were no public comments for or against the rezoning. The council discussed the open space donation that is required by ordinance. A decision will be made at a later date. A second reading will be held at the April 16, 2018 meeting.

**JOINT POWERS AGREEMENT FOR USE OF REGIONAL WASTEWATER SYSTEM.** Jason reviewed the Joint Powers Agreement For Use of Regional Wastewater System between the City of Tea and the City of Sioux Falls. The final agreement will be approved at a later date.

**HERITAGE ADDITION INTIAL DEVELOPMENT PLAN.** Ben provided the council with HDR's review of the Heritage Addition Initial Development Plan. The next step is the submission of a Preliminary Development Plan.

**N MAIN AVE. EXTENSION COST SHARE AGREEMENT.** Ben briefly reviewed the oversizing cost for extending services on North Main Ave.

**WETLANDS FUNCTIONAL CAPACITY UNIT CREDITS PURCHASE CONTRACT.** Ben presented a contract for the purchase of capacity unit credits from Tetonka Wetland Mitigation Bank II. These credits would meet the requirements for the project on 271<sup>st</sup> street. **MOTION 18-62. MOTION** by Fowlds, seconded by Boots to approve the contract and purchase 2.5 acres of wetland credits from the Tentonka Weland Mitigation Bank for a total cost of \$75,662.50. All members voted AYE.

**271**<sup>ST</sup> **ST. IMPROVEMENTS PROJECTS CHANGE ORDER 1.** Ben informed the council that there was a change order for a manhole within the project. The original plans called for a drop structure of the manhole to be ordered, but the costs for that drop structure were not accounted for within the plan. **MOTION 18-63. MOTION**

by Weis, seconded by Fowlds to approve Change Order 1 for the 271st St Project for an increase of \$5,600. All members voted AYE.

**AMERICA ENGINEERING TESTING INC. CONTRACT** The council reviewed the contract from American Engineering Testing, Inc. for the Quality Control Testing required for the 271<sup>st</sup> St. Improvements Project. **MOTION 18-64. MOTION** by Boots, seconded by Weis to approve the American Engineering Testing Inc., Contract in an amount not to exceed \$45,000. All members voted AYE.

HAUGAN INVESTMENTS LIMITED PARTNERSHIP ANEXATION AGREEMENT. The council reviewed the annexation agreement between Haugan Investments Limited Partnership and the City of Tea. There was discussion about the annexation fees and the costs of moving sewer line. MOTION 18-65. MOTION by Fowlds, seconded by Weis to approve the Annexation Agreement between Haugan Investments Limited Partnership and the City of Tea, contingent upon deleting item number III from the agreement. All members voted AYE.

MOTION 18-66. MOTION by Weis, seconded by Fowlds to adjourn at 9:02 pm. All members voted AYE.
