PUBLIC COMMENT POLICY. RESOLUTION 18-07-24 – PUBLIC COMMENT POLICY. MOTION 18-152. MOTION by Ortmeier, seconded by Boots to approve the following resolution. All members voted AYE. WHEREAS, HB1172 requires that any public body reserve, at every official meeting of the public body, a period for public comment, limited at the Mayor's discretion, but not so limited as to provide for no public comment.; AND WHEREAS, IT IS APPROPRIATE FOR THE City to have rules to govern the public comment time, NOW THEREFORE, BE IT RESOLVED that the Tea City Council adopts the following rules for public comment:

- 1. At the opening of every meeting, fifteen (15) minutes will be set aside to hear any citizen who wishes to address the Council.
- 2. No action will be taken during the meeting at which the item is presented; however, it may be placed on the agenda for a future meeting
- 3. Each person must identify himself or herself by name and address.
- 4. Each person may speak about any item of concern.
- 5. Each person may speak for a maximum of three (3) minutes
- 6. Each person may exceed the three (3) minute limit only by unanimous consent of the Council after three (3) minutes have expired
- 7. At the end of fifteen (15) minutes, the public comment time will end.
- 8. The Mayor may, at his or her discretion, interrupt or terminate any testimony if a citizen becomes unruly or disruptive.
