WHEREAS, the Tea City Council believes that is it necessary and in the best interest of the City of Tea, in order to pay all costs for the operation, maintenance and improvements of the City's sewer system, to amend the rates for the collection and disposal of wastewater provided by the City of Tea; NOW THEREFORE, BE IT RESOLVED by the Tea City Council as follows: 1. All residential single-family customers shall pay a flat fee of \$32.00 per month. 2. All Multi-Family customers shall pay \$32.00 per living unit per month. 3. All commercial customers shall pay \$32.00 per month. 2018.
