WHEREAS, the City of Tea has contracted with the City of Sioux Falls for the treatment of wastewater under terms and conditions set forth in the Joint Powers Agreement for Use of Regional Wastewater System, dated June 1, 2018; and WHEREAS, Section 21 of the Joint Powers Agreement for Use of Regional Wastewater System requires the City of Tea to pay Regional System Development Charges (Regional SDC) to the City of Sioux Falls for each new sewer connection to the City of Tea wastewater collection system: and WHEREAS, the amount of the Regional SDC charge, based on the size of the water meter, shall be established by the City of Sioux Falls by ordinance and amended from time to time; NOW, THEREFORE BE IT RESOLVED that the following Regional SDC charges, as currently established by the City of Sioux Falls, shall be collected by the City of Tea for each new water meter installed:

5/8" and 3/4" meter	\$ 2,391.00
1" meter	\$ 5,978.00
1-1/2" meter	\$ 11,954.00
2" meter	\$ 19,127.00
3" meter	\$ 35,863.00
4" meter	\$ 60,000.00
6" meter	\$ 119,550.00

BE IT FURTHER RESOLVED, that the Regional SDC charges shall be due and payable prior to the installation of each water meter; and **BE IT FURTHER RESOLVED** that the Regional SDC charges shall be adjusted from time to time as the City of Sioux Falls reviews and amends such charges.
