City of Tea Regular Meeting October 7, 2019

A regular meeting of the Tea City Council was held at Tea City Hall on October 7, 2019 at 7:00 pm.

Mayor John Lawler called the meeting to order with the following members present: Sidney Munson, Jim Erck, Chuck Ortmeier, Joe Weis, Casey Voelker and Todd Boots. Also present: Finance Officer Dawn Murphy, Planning & Zoning Administrator Kevin Nissen and City Administrator Dan Zulkosky.

**PUBLIC COMMENTS.** There were no public comments.

**AGENDA. MOTION 19-181. MOTION** by Ortmeier, seconded by Weis to approve the October 7, 2019 agenda. All members voted AYE.

**MINUTES. MOTION 19-182. MOTION** by Weis, seconded by Ortmeier to approve the September 16, 2019 minutes. All members voted AYE.

**WARRANTS. MOTION 19-183. MOTION** by Munson, seconded by Erck to approve the September warrants as presented. All members voted AYE. Warrants will be listed at the end of the minutes.

**SITE PLAN.** Kevin presented and recommended approval of a site plan for a 6,000 sq. ft. retail building in the Bakker Landing Addition. **MOTION 19-184. MOTION** by Boots, seconded by Voelker to approve the site plan for Hegg Construction to construct a 6,000 sq. ft. retail building at 2215 Bakker Landing and Industrial Street All members voted AYE.

**REVISED PRELIMINARY PLAN.** Kevin presented and recommended approval of a revised preliminary plan for the Gateway Addition. The revision removed a portion of Remington Avenue and looped the road over to Heritage Parkway. The lot layout was redesigned to meet the access requirements and will allow parking on one side of the street. The proposed zoning does show multi-family residential along Nine Mile Creek. The developer is requiring onsite detention on each lot. **MOTION 19-185. MOTION** by Boots, seconded by Weis to approve the revised Gateway Addition Preliminary Plan for Arlyn Olsen. All members voted AYE.

**7:15 PUBLIC HEARING.** Mayor Lawler opened the public hearing for Ma's and Pa's Preliminary Development Plan. This three-lot development plan involves extending Maple Street west to the edge of the development. The drainage plan would limit water going east to Elsie. The plans incorporated a temporary 20' asphalt road to 468<sup>th</sup> Street as secondary access. There were no comments for or against the project. **MOTION 19-186. MOTION** by Boots, seconded by Weis to approve Ma's and Pa's Preliminary Development Plan for Herman Otten. All members voted AYE.

**PLAT.** Kevin presented and recommended approval of a plat in Pinnacle Estates Addition. **MOTION 19-187 RESOLUTION 19-10-26. MOTION** by Boots, seconded by Voelker to approve the following resolution. All members voted AYE. **BE IT RESOLVED** by the City Council of the City of Tea, South Dakota, that the plat known and described as Lots 3-10, Block 5, Pinnacle Estates Addition, lying within jurisdictional limits of the City of Tea, South Dakota, is hereby approved and the City Finance Officer of the City of Tea, South Dakota is hereby directed to endorse on such plat a copy of this resolution and certify the same thereon.
