The regular meeting of the Tea City Council was held at Tea City Hall on June 2, 2025 at 6:00 pm.

Mayor Casey Voelker called the meeting to order at 6:00 pm with the following members present: Aaron Otten, James Erck, Terry Woessner, Josh Chapman, Lynn DeYoung and Ruby Zuraff. Also present: City Administrator Justin Weiland and Finance Officer Dawn Murphy. Absent: City Engineer Ben Scholtz and Community Development Director Albert Schmidt.

AGENDA. MOTION 25-66. MOTION by Otten, seconded by Chapman to approve the June 2, 2025 Agenda. All members voted AYE.

PUBLIC COMMENTS. Sarah Bastemeyer spoke about the excessive speeding on 7th St. and asked that the Emily's Hope Fireworks Display pick up better.

CONDITIONAL USE PERMIT. Mayor Voelker opened the Conditional Use Permit Public Hearing for a wireless communication facility in a R-2 Residential Planned Development District. Several residents were present to voice their objections to the facility. Mr. Nielson will get additional information on the building. No action was taken.

PUBLIC HEARING. Mayor Voelker opened the public hearing for temporary alcohol beverage licenses for the City of Tea and Squealers Smoke Shack. There were no comments for or against the licenses. **MOTION 25-67. MOTION** by Erck, seconded by Chapman to approve the following Temporary Retail On-Sale Alcohol Licenses:

- 1) City of Tea, Lots 9-12, Block, 11 & Bakker Tract 2, Lots 8, 9 & 10 (Tea City Park), June 20 & 21
- 2) Squealer Smoke Shack, Tea Athletic Park Addition, Lot 1, Limited to the concession stand and parking lot areas, June 20.

All members voted AYE.

DOG RUNNING AT LARGE VIOLATION APPEAL. Sarah Bastemeyer was present to appeal a dog running at large violation ticket. The ticket was issued after a warning was previously issued. **MOTION 25-68. MOTION** by Otten, seconded by Erck to deny the dog running at large ticket. All members voted AYE.

TITANS TAVERN. Representatives from Titans Tavern were present to ask permission for an outdoor concert on June 20 and to close a portion of 2nd street on June 21st. **MOTION 25-69. MOTION** by DeYoung, seconded by Woessner to approve the outdoor concert on June 20 and to approve the blocking of 2nd Street from Main Ave east to the alley. All members voted AYE.

SMGA ECONOMIC DEVELOPMENT MANAGEMENT SERVICES CONTRACT. Tyler Tordson, President of Sioux Metro Growth Association was present to discuss the proposal for economic development professional services. The cost to the City the first year is \$75,000 for the remainder of 2025 and \$50.000 for 2026. The specialist would work an average of 16 hours per week. There was a lengthy discussion. **MOTION 25-70. MOTION** by DeYoung, seconded by Zuraff to approve the SMGA Economic Development Management Services Agreement. Members DeYoung, Zuraff and Otten voted AYE. Members Woessner, Chapman and Erck voted NO. Motion failed due to a lack of a majority.
