City of Tea Regular Meeting June 16, 2025

The regular meeting of the Tea City Council was held at Tea City Hall on June 16, 2025 at 6:00 pm.

Mayor Casey Voelker called the meeting to order at 6:00 pm with the following members present: Aaron Otten, James Erck, Terry Woessner, Josh Chapman, Lynn DeYoung and Ruby Zuraff. Also present: City Administrator Justin Weiland, Finance Officer Dawn Murphy, City Engineer Ben Scholtz and Community Development Director Albert Schmidt.

**AGENDA. MOTION 25-72. MOTION** by Woessner, seconded by Otten to approve the June 16, 2025 Agenda. All members voted AYE.

**CONSENT AGENDA**. **MOTION 25-73. MOTION** by Otten, seconded by Chapman to approve the following consent agenda items:

All members voted AYE.

PUBLIC COMMENTS. There were no comments.

**VARIANCE PUBLIC HEARING**. The City Council acting as the planning and zoning board of adjustment reviewed a rear yard setback variance request. The property owner would like to extend their covered deck 5 feet and then convert the covered deck into a livable space. The current deck is built to the required 25-foot setback and by extending the deck it would encroach into the required setback. Community Development Director Schmidt recommend the board deny the request based on the request not meeting the hardship variance standards. **MOTION 25-74. MOTION** by Erck, seconded by Chapman to approve the set back variance for Brett Somsen, 2525 N. Ivy Rd. All members voted AYE.

**LINCOLN COUNTY EMERGENCY MANAGEMENT.** Harold Timmerman, Lincoln County Emergency Manager, gave his yearly report to the council.

SMGA ECONOMIC DEVELOPMENT DIRECTOR MANAGEMENT SERVICES. Tyle Tordsen, SMGA President was present to answer any question regarding the management services contract. The contract will be discussed further in executive session.

**BULDING PLANS.** Community Development Director Schmidt presented the building plans for Gateway Park Extended Stay Motel which will include one large unit, three smaller units, one suite with golf simulators and laundry facilities. **MOTION 25-75. MOTION** by DeYoung, seconded by Chapman to approve the Gateway Park Extended Stay Motel Building Plan for DST Holdings, 815 N. Gateway Lane. All members voted AYE.

Community Development Director Schmidt reported that the planning and zoning board has adopted new Bylaws for the Tea Planning Commission.

**REQUEST FOR PROPOSALS. MOTION 25-75. MOTION** by Otten, seconded by Zuraff to authorize City Administrator Weiland to advertise for a Request for Proposals for a new street maintenance shop – design build. All members voted AYE.

**SAFETY ACTION PLAN. MOTION 25-76. MOTION** by DeYoung, seconded by Otten to approve Resolution 25-06-03. All members voted AYE. **RESOLUTION #25-06-03. ADOPTING RESOLUTION FOR THE TEA AREA SAFETY ACTION PLAN**

(SAP) AND CITY OF TEA VISION ZERO SAFETY GOAL COMMITMENT. WHEREAS, Federal regulations require all states to have a Strategic Highway Safety Plan (SHSP) that provides a comprehensive framework for reducing fatalities and serious injuries on public roadways; and WHEREAS, recent safety data in South Dakota shows that between 2019 and 2023 annual traffic fatalities have increased 38% and serious injuries have increased 10%; and WHEREAS, the South Dakota Department of Transportation (SDDOT) is acting in cooperation with local communities to alter this trend through development and adoption of the 2024 South Dakota SHSP, a multi-disciplinary and data-driven effort to reduce fatalities and serious injuries across all public roads in South Dakota with goals to reduce traffic fatalities to 100 or fewer and serious injuries by 400 or fewer by 2029 (30% reduction); and WHEREAS, the City of Tea and surrounding area experienced 11 fatal and serious injury crashes between the years 2019 and 2023; and WHEREAS, the City of Tea, in conjunction with surrounding agencies including the City of Sioux Falls, Lincoln County, South Eastern Coalition of Governments (SECOG) / Sioux Falls Metropolitan Planning Organization (MPO), South Dakota Department of Transportation (SDDOT), and the Federal Highway Administration (FHWA), performed a safety analysis for the Tea area utilizing crash records and traffic data consistent with the Safe Streets for All (SS4A) program guidelines as part of the Tea Area Transportation Plan; and WHEREAS, the Tea Area Safety Action Plan (SAP) study area consists of all State, County, Township, and City owned roads, except Interstate 29, within the Tea Area Transportation Plan study area boundaries; and WHEREAS, based on the safety analysis, the Tea Area SAP was prepared with an aim to reduce and eliminate fatal and serious injuries across all roadway users in the City of Tea and surrounding growth areas including vulnerable road users (pedestrians, bicyclists, and personal conveyance device users), transit riders, and motorists; and WHEREAS, one of the eight required components of a SS4A SAP is "Leadership Commitment and Goal Setting" towards an eventual goal of zero roadway fatalities and serious injuries and the proposed Tea Area SAP consists of policy and project recommendations to achieve a long-term goal of eliminating roadway fatalities and serious injuries by 2050, consistent with the U.S. Department of Transportation's (USDOT) Safe System Approach (SSA), also adopted by the SDDOT in the 2024 South Dakota SHSP and 2023 South Dakota Vulnerable Road User Safety Assessment (VRUSA), and Vision Zero which align with best practices nationally to prioritize human life and creating a safe transportation network for all users; and WHEREAS, the Tea Area SAP will meet the requirements to allow the City of Tea to apply for Implementation Grants from the USDOT SS4A discretionary grant program to fund improvements and strategies to reduce fatalities and serious injuries of all roadway users; and WHEREAS, the Council finds the proposed Tea Area SAP is based on federal, state, and local standards and provides for the health, safety, and welfare of the community and will support and guide the City's planning, investment, and policy decisions: NOW THEREFORE BE IT RESOLVED, the City Council hereby authorizes the following items: The City of Tea hereby commits to the 'City of Tea Vision Zero', a long-term goal of zero roadway fatalities and serious injuries by 2050 within the City and surrounding growth areas. The City pledges to use its resources, influence, and partnerships to make significant strides towards this outcome. The City of Tea recognizes that a share of the fatal and/or serious injury crashes within the surrounding Tea area, occur on other jurisdictional roadways. Coordination with partners at the City of Sioux Falls, Lincoln County, SECOG/Sioux Falls Area MPO, and SDDOT will be necessary to achieve a goal of zero roadway fatalities and serious injuries. Per the SAP, the City will focus and prioritize safety improvement locations within city limits and update the plan upon relevant roadway jurisdictional transfers. The City of Tea will strive to make progress toward the stated reduction targets by working within the framework of the Tea Area SAP to achieve the goals, and it will monitor progress annually and adjust the plan as necessary to maintain momentum toward the ultimate goal of zero roadway fatalities and serious injuries. The City of Tea hereby approves and adopts the proposed Tea Area SAP in conjunction with the Tea Area Transportation Plan (TATP) and designates the Mayor to act as signatory in connection with future SS4A grant applications and related forms and to provide such additional information as may be required by the USDOT. This Resolution shall be effective after its passage and approval according to law. Adopted this 16th day of June, 2025.
